







1. The minutes of the 3<sup>rd</sup> BOS meeting held on 18.03.2025 were review by the members prior to this meeting.

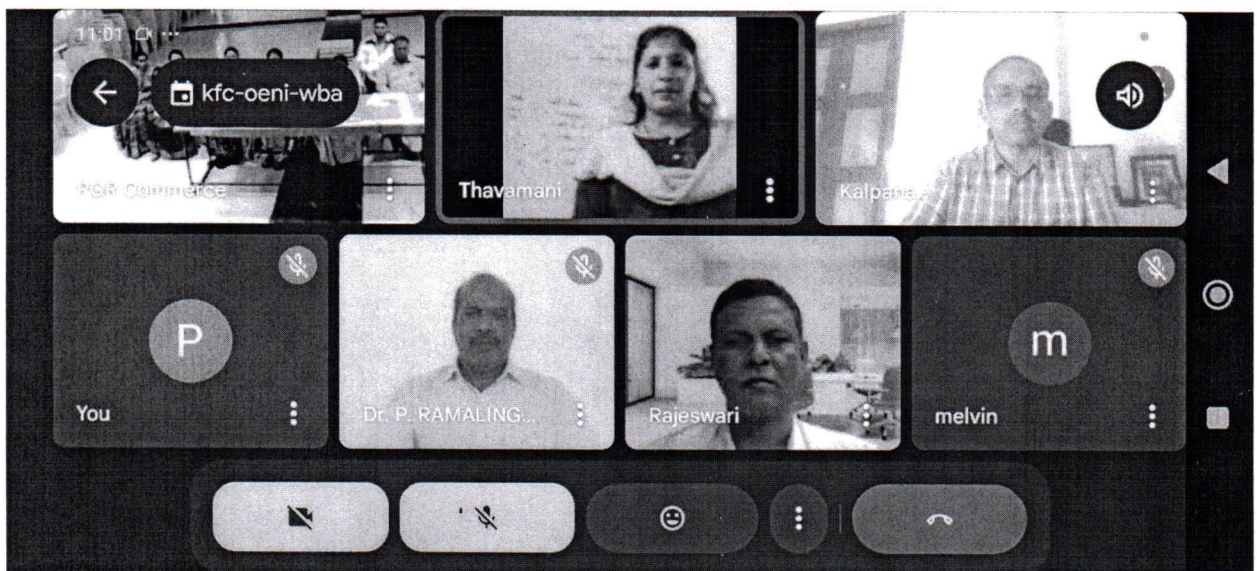
